Notes: Valid attendance forms must be completed, signed and sent to the registered office of Zavarovalnica Triglav d.d. at Miklošiceva 19, 1000 Ljubljana, due to arrive no later than by the end of the fourth day preceding the date of the General Meeting of Shareholders, that is by the end of 31 May 2024. A shareholder with the right to attend the General Meeting of Shareholders may authorise a proxy to attend the meeting and exercise their voting rights at the General Meeting of Shareholders. The written authorisation must be submitted no later than by the opening of the General Meeting of Shareholders. The shareholder may submit the written authorisation to Zavarovalnici Triglav, d.d., also via email to the address investor.relations@triglav.si. The authorisation to be sent by email must be signed with a qualified electronic signature of the natural person and, in case of legal entities, by the legal representative and a stamp, if used by the legal entity.

The written authorisation shall stay remain stored with the company. By signing this form, the shareholder and the proxy approve that Zavarovalnica Triglav, as a controller of personal data, processes and stores their personal data from this form, together with the data from the shareholder's book, for the purpose of carrying out the general meeting and voting at the general meeting, until the expiry of the statutory deadline for such data retention.

With the said acknowledgement of receipt, it is easier for the proxy to identify himself/herself at the entrance of the General Meeting on the day of the session, which provides for faster registration of shareholders and proxies at the entrance.
